

### **Important Information**

The speed of the eCRF has been optimized, data entry is now faster compared to previous versions of the eCRF.

With regard of a Follow Up period: The first Follow Up period starts four weeks after the last completed LEN cycle was started and lasts for one year. Please enter data of the most recent visit of your patient before the end of the Follow Up period. The second and following Follow Up periods last again for one year each. Data of the most recent visit of your patients before the end of each Follow Up period have to be entered.

Please remember that you are entitled to receive a compensation for every registered patient (at registration 200 CHF, at last Follow-up 100 CHF). You will find the invoice after your Log-in at the Homepage www.slim-registry.ch.
