

Important Information

There is the possibility of **data entry of new LEN-cycles** in patients who receive a **second course of Lenalidomid** after the first course of LEN-cycles was stopped, sometimes many months or years thereafter. You can do so after entering data in the "Follow-Up"-section and answering the question "Treatment of disease progression" with "Lenalidomid". After that you can go to the section "LEN Cycles" to enter data of the new, second course of LEN-Cycles.

The eCRF was amended making data entry possible with regard to **molecular genetics in every diagnostic evaluation** with the focus on *JAK2 V617F*, *p53* and others.
